Transportation

- 5 potential drivers going for training. Road tests will likely be mid-October
- Bus evacuation training/practices for students starts October 7 and will go for a few weeks across the division.

Finance

- The year end statements should be available October 15th for the board to review and approve.
- Anticipated retro pay for teachers will occur November 15th. The month of October will be preparing and reviewing the retro calculations for approximately 509 teachers.
- School administrators will receive their admin allowances in the month of October with the new collective agreement rates and after staffing and student head count has been finalized.

ICT

- Printing issue that arose from incompatibilities between Windows 11 and Impero implementation of new equipment and operating system in all schools is complete and has gone extremely well.
- ICT director will be doing school visits to every school in the Division for the rest of September and into October before the snow flies
- A test of the Emergency Messaging System (PowerSchool SchoolMessenger) for all staff will be conducted on Monday Sept 30 at 7PM

Maintenance

- 4ft fence will be installed. The quote will be shared with the RM of Springfield within the week to discuss funding request.
- Springfield Collegiate Building envelope, mechanical and roof replacement –
 Chiller is up and running. The manufacture of the chiller had to adjust sensors
 regarding voltage to prevent the unit from tripping a breaker and shutting off.
 Reports of uneven temperature in classrooms are occurring, project manager
 identifies that is do to the system needing to be balanced and removing any
 air in the classroom units and mechanical lines and overall system.
