Notice of Impending Spring Restrictions on Municipal Roads

Each year, the Municipal Road infrastructure is weakened by the Spring thaw. To reduce damage to our roads, reduced vehicle weights are applied to Municipal roads. This year, dependant on weather conditions, restrictions will be applied similar to the dates chosen by the Province, which will tentatively commence March 18th, 2024 at 6:00 am and will remain in effect until midnight on May 5th, 2024. *Municipality has the authority to change these dates being earlier or later depending on weather and road conditions.

During this time posted roads will be limited to Level 2 B1 Highway (65% of normal axle loads) and may remain in effect for

Since restrictions are dependent on weather our website will be updated regularly to reflect any changes at www.rmofspringfield.ca Updates can be found under Municipal Services>Public Works > Spring Road Restrictions or on the home page.

The Rural Municipality of Springfield would like to remind residents interested in applying for the application of seasonal dust control, the RM is now accepting orders for the 2024

Applications will be received at the Public Works Building located at 27055 Oakwood Rd. Unit 2, up to and including April 30th of each year, or if April 30th falls on a weekend it will be the next business day. The rate will be 50% of the actual rate of the current application cost. The annual cost shall be determined, and advertised, in the month of March and April of each year, and will be posted to the RM's web site. The cost for the 2024 season for residents will be \$.55 cents per foot (50% cost share), this includes all taxes. The cost to residents after April 30 will be \$1.010 cents per foot. The Department accepts cash, cheque and Interac as forms of payment.

A minimum of 45 meters (150 feet) of dust suppressant is required, and not more than a 4.8-meter width (16 feet) is allowed unless deemed necessary by the Public Works Department.

The Municipality cannot guarantee the effectiveness of the dust control suppressant. Once a dust control suppressant has been applied, no refunds will be made. The use of a dust suppressant is meant to control dust on the roadway, not to eliminate it completely.

The Municipality will not be responsible for any private dust control product applied to the roadway by a resident, and will maintain the roadway as deemed appropriate by the Public Works Department.

The Public Works office is open Monday to Thursday from 7:00 am to 4:30 pm and Friday 7:00 am to 3:30 pm. Please note that the Office is closed daily between 12:00 and 12:30 pm.
